### NOTE

Under Internal Revenue Regulations, tax-exempt charitable organizations generally must provide requesters with COPIES of:

- Its approved exemption applications, all required attachments and any related correspondence with the IRS, and
- Its three most recent annual information returns (Form 990), including all schedules and attachments (but not the names and addresses of contributors).

**In-person requests:** *A member of the public may request to inspect the documents at any principal office of the organization. The entity must provide the information requested that same day. However, if the request places an “unreasonable burden” on the organization, the staff must provide copies of the requested information no later than the next business day after the unusual circumstances cease to exist (limited to a maximum of five business days after the request).*

**Written requests:** *Written requests made by fax, mail, email, or overnight service, which include the requester’s address, must be honored within 30 days of receipt.*

**Website alternative:** *Instead of providing copies, an organization may make the documents available on either its own or another organization's website. If it uses this option, it has to: (1) provide an exact replica of the document as was filed with the IRS; (2) advise requesters how to access the forms on the web; (3) the site should charge no access fee and require no special software or hardware to download. Organizations that post this information on the Internet still must honor in-person requests to view the applicable documents.*

**Permissible charges:** *Tax-exempt organizations may charge a reasonable copying fee, up to \$1 for the first page and 15 cents for each additional page, plus actual postage costs.*

**Penalties:** *An organization that fails to comply with the new disclosure requirements may be subject to the following penalties:*

- Annual Information Return – Form 990 - \$20 per day for as long as the failure continues, up to a maximum of \$10,000 for each failure to provide an annual return.
- Exemption Application - \$20 per day with no maximum.
- An organization that willfully fails to comply with these public inspection rules can be subject to an additional \$5,000 penalty.

**Private foundation exempt:** *The new disclosure rules don't yet apply to private foundations. They must still make a copy of their annual return available for public inspection at their principal office for a period of 180 days after publishing a notice of availability.*

Zimbabwe - CWO operates a mobile orphan ministry called "Our Kids" which is derived from the African concept that views every child in a community as belonging to everyone in the community. This program allows children to stay in the communities in which they have been born instead of being institutionalized. Providing home care, food and scholarships, children in the Our Kids program receive on-going counseling, AIDS education, skills development, and opportunities for micro-income generating projects and weekend life skills camps. Currently 370 children are being supported through the Our Kids program. CWO provides training for local church Pastors and community leaders. There were 14 guardians who received loans to start business to support their families and the orphan(s) they have brought into

Haiti - Christian World Outreach (CWO) began working in Haiti in 1978 and is currently operating a children's feeding program, a church development program, a leadership development program, evangelistic camps, and a vocational training center. CWO feeds an average of 80 children three times a week from the neighborhood around its headquarters. Approximately 11,800 meals were served in 2014. CWO is currently working with eight partner churches which are located mostly in rural and remote areas of northeast Haiti, to help the pastor's develop strong ministries that reach out to men, women, and youth in their communities. Part of the A3work with the churches is training sessions teaching pastors and lay-leaders how to deal with the practical and spiritual questions people are facing on a daily basis.

4c (Code: ) (Expenses \$ 207,895. including grants of \$ 0.) (Revenue \$ 0.) Burkina Faso - Christian World Outreach (CWO) began working in Burkina in 2001 and has developed a vocational training center for young ladies, developed and continuing to test an agriculture program, has created a learning library, and has developed a mobile clinic. Classes in sewing are being conducted in the newly constructed vocational school building where young ladies are learning to sew and crochet. There are currently 36 young ladies attending classes. The goal of the vocational training center is to provide classes in sewing, cooking, cosmetology, crafts, English, French, business, and Bible so the young ladies can improve their lives and those in the villages they come from. Shade houses are being used as a training tool for the young ladies where produce is grown year round. There are now five 90 foot

CWO created a free learning resource library in Zimbabwe to provide

In 2014, 120 pastors and leaders attended the annual leadership  
conference. Two evangelistic camps were held which were attended by

women with vocational skills so they are able to obtain employment or  
start their own business and provide for their families. The women  
learn skills in sewing, cooking, cake decorating, crafts and  
cosmetology. In 2014, approximately 91 ladies graduated from FTC  
classes. Some of these ladies attended a crash course in cooking in  
backing. This was offered from July to September to 36 ladies because  
of the need of some single mothers to provide financial stability for

shade houses being used to produce vegetables which are used to feed the students at the vocational school and to supplement the food given to 500 children in a nearby school. CWO+C50 has developed a mobile clinic which is taking health and medical care to the people in the villages as well as one prison. They have treated 1,260 people in visits by the end of 2014. There were 350 people who came to the mobile clinic and also families of those attending the school who also received aid in the form of food and clothing. The learning library is divided into two sections. The first is available to 500 children who have never had access to books in their villages. There are about 100 per week who are read to in groups, tutored in reading, and read during their free time. The second is for the young women in the vocational school. They are able to read books on the subjects they are learning as well as read for pleasure improving their reading skills.

Zambia - Christian World Outreach field staff in Zambia have created a HIV/AIDS prevention & education program that combats the stigma often associated with the disease, teaches sustainable prevention, and focuses on care for those who have HIV/AIDS. HIV/AIDS education is taught weekly at Anti-AIDS clubs, primary schools and universities, community groups, youth groups and churches. CWO is also a partner with the Zambian Police Service and provides HIV/AIDS publications and trainings specific to their field of work. They attended seminars and classes to learn of ways they can remain HIV free, how to reduce the spread of the disease, where to go for treatment and testing, how to
